Charter Against Scams

Gweithio gyda'n gilydd i
helpu i ddiogelu pobl Cymru
rhag sgamiau a thwyll, ac i
gynorthwyo dioddefwyr.

Working together to help
better protect people in Wales
from scams and fraud, and to
support victims.

Gall cael eich sgamio neu eich targedu gan dwyll gael effaith ddinistriol ar rai o'r bobl fwyaf agored i niwed yng Nghymru.

Mae sgamiau'n targedu pawb a gallai pob un ohonom gael ein twyllo gan ddynt. Credir bod o leiaf 150,000 o bobl yng Nghymru yn cael eu twyllo gan sgamiau bob blwyddyn.

Yn gyffredinol, mae pobl hŷn yn dioddef ddwywaith y golled ag y mae pobl ifanc yn ei dioddef, ac amcangyfrifir bod dioddefwyr hŷn yn colli, ar gyfartaledd, £1,200 yr un. Mae rhai pobl hyd yn oed yn fwy agored i niwed am amrywiaeth o resymau, gan gynnwys tlodi, unigedd, llesgedd, nam gwybyddol, ac oherwydd y cânt eu targedu'n benodol.

Credwn y gall Cymru arwain o ran sefyll ynghyd yn erbyn sgamiau a gwneud ei hun yn wlad anghyfeillgar i sgamwyr.

Being scammed or targeted by fraud can have a devastating impact on some of the most vulnerable people in Wales.

Scams target everyone and all of us could fall prey to them. At least 150,000 people in Wales are believed to be victims of scams each year.

In general older people suffer twice the detriment that younger people do and it is estimated that older victims lose on average £1200 each. Some people are additionally vulnerable for a variety of reasons, including poverty, isolation, frailty, cognitive impairment and because they are specifically targeted.

We believe Wales can lead in presenting a united front against scams and making itself a hostile country to scammers.

Byddwn yn

- Gwella ymwybyddiaeth y cyhoedd o sgamiau a thwyll, a chynyddu gwybodaeth am y camau y gall pobl eu cymryd i amddiffyn eu hunain.
- Cael gwared ar stigma ac embaras ynghylch bod yn dioddefwr sgamiau a sicrhau bod dioddefwyr yn cael eu cynorthwyo yn yr un modd â dioddefwyr troseddau eraill.
- Rhannu negeseuon cyson â'r cyhoedd a'r cyfryngau.

1 Raising awareness and de-stigmatising scams

We will

- Improve public awareness of scams and fraud and increase knowledge about the steps people can take to protect themselves.
- Remove stigma and embarrassment about being a victim of scams and ensure that victims are as well supported as victims of other crimes.
- Share consistent messaging to the public and media.

2 Atal ac amddiffyn

Byddwn yn

- Cynyddu amddiffyniad ar gyfer pawb, yn enwedig pobl sy'n agored i niwed, yn erbyn sgamiau a thwyll.
- Cymryd camau i'w gwneud hi'n anoddach i bobl gael eu targedu gan sgamwyr.
- Cyflwyno rhwystrau ac amddiffyniadau cryfach ar y mecanweithiau y mae troseggwyr yn eu defnyddio i gyrraedd eu dioddefwyr.

3 Amlygu a chofnodi

Byddwn yn

- Gwella'r broses o ganfod dioddefwyr sgamiau a thwyll, a sicrhau y cant gynnig cymorth priodol a mynediad at gyfiawnder.
- Cyflwyno diffiniadau a chofnodi cyson o sgamiau i gynorthwyo i ddeall gwir raddfa eu heffaith.
- Datblygu llwybrau cydweithio a chyfeirio gwell rhwng sefydliadau a llwybrau cymorth cyffredin i ddioddefwyr.

4 Gorfodi, mynediad at gyfiawnder ac adfer

Byddwn yn

- Sicrhau y darperir atebion a chymorth parhaus i ddioddefwyr sgamiau, gan gynnwys cymorth ariannol priodol i'r rheiny sydd wedi colli arian.
- Ceisio erlyn troseggwyr a chael cyfiawnder i ddioddefwyr.
- Gorfodi cosbau ac ataliadau effeithiol yn erbyn troseggwyr, gan gynnwys canslo contractau, dirwyon ac atafaelu asedau.
- Ceisio adfer ymdeimlad o les a hyder i ddioddefwyr.

2 Prevention and protection

We will

- Increase the protection everyone, and especially vulnerable people, have against scams and fraud.
- Take steps to make it more difficult for people to be targeted by scammers.
- Introduce stronger barriers and safeguards on the mechanisms used by perpetrators to reach their victims.

3 Identification and recording

We will

- Improve the identification of victims of scams and fraud and ensure they are offered appropriate support and access to justice.
- Introduce consistent definitions and recording of scams to aid understanding of the true scale of their impact.
- Develop improved joint-working and referral pathways between organisations and common support pathways for victims.

4 Enforcement, access to justice and restoration

We will

- Ensure appropriate remedies and ongoing support is provided to victims of scams, including appropriate financial support to those who have lost money.
- Seek to prosecute perpetrators and achieve justice for victims.
- Enforce effective punishments and deterrents against perpetrators, including cancelling of contracts, fines and seizing of assets.
- Seek to restore a sense of wellbeing and confidence to victims.
