## 3.4 million over 65s have never used the internet. A further half a million have used it in the past but no longer do so, and by the age of 75 the majority are not online.

### 118,000 older EU citizens living in the UK must apply for settled status.

Age UK estimates there are 118,000 EU nationals (not Irish or UK) aged 65 and over living in the UK. This is based on analysis of the 2018 Annual Population Survey, scaled up to the UK population using the Office for National Statistics mid-year population estimates for 2018.

## Pensioner poverty has risen: 1.6 million pensioners in England and 2 million in the UK were in poverty in 2017/18 and a further million in the UK were just above the threshold.

### 18% of people aged 60-64 in the UK were in poverty in 2017/18.

Data extracted from DWP Stat-Xplore shows that 640,751 people aged 60-64 in the UK in 2017/18 were in poverty, of a total of 3,553,475 people in this age group. This is 18%.

# Changes to Pension Credit rules for 'mixed age couples' (pensioners with a partner under State Pension age) mean that some couples with an age gap of five years or more could lose £35,000 by the time the younger partner reaches SPA.

Age UK has estimated that 31% of couples have an age gap of five years or greater, using data on the ages of partners in 10,941 co-resident opposite sex couples aged 16+ living across the UK, who were surveyed in wave 8 of Understanding Society, the UK Household Longitudinal Study in 2016-18. The difference between standard Universal Credit (£115 per week) and standard Pension Credit (£255.25 per week) for couples is £140.25 each week. If rates were to stay the same, over five years this difference would accumulate to £36,465.



## An older person is the victim of fraud every 40 seconds, equivalent to 800,000 older people a year.

Age UK analysis of the Crime Survey for England and Wales 2017/18 indicates that 7.8% of people aged 65+ in England and Wales reported that they had been a victim of fraud in the 12 months prior to being interviewed. When 7.8% is projected onto the 10,384,697 sample-adjusted population of people aged 65+ in England and Wales, as provided by CSEW, it gives an estimate of 813,000 older victims of fraud, equivalent to an average of one every 38.8 seconds.

## 1.1 million older people in England live in unfit housing characterised by problems such as damp, rot, infestations, electrical and plumbing problems.

### 750,000 older people are renting from private landlords

Age UK analysis of the English Housing Survey 2017-18. 5.6% of people aged 60 and over in England are estimated to be living in the private rented sector, equivalent to 745,000 people. In this estimate, households with members aged both below 60 and above 60 are assumed to only have one person aged 60 and over living in them; this leads to a small underestimation of the number of people aged 60 or over living in the private rented sector, for instance in cases where a household of three or more includes one person aged under 60 and more than one of the remaining household members are aged over 60.

### One in three older private renters are living in poverty

Age UK analysis of the English Housing Survey 2017-18. The percentage of people aged 60 or over living in the private rented sector who have a household income below 60% of the median household income (after housing costs) is estimated to be 34%.

### Two in five older private renters are in poor health.

Age UK analysis of wave 8 of the English Longitudinal Study of Ageing, collected 2016-17. The proportion of people aged 60 or over living in the private rented sector that have a long-standing illness that limits their day to day activities is estimated to be 43%.



### Around 1 million people aged 60+ in England live in a fuel-poor household.

Statistics on the numbers of older people living in fuel poverty are not published, however BEIS publishes estimates of the number of households in fuel poverty, by both the age of the youngest member of the household and the age of the oldest member of the household. There are 509,000 households in fuel poverty in which the youngest person is aged 60+ and 716,000 households in fuel poverty in which the oldest person is aged 60+. Age UK estimate that around 1 million older people are likely to be living in households in fuel poverty.

## Loneliness affects 0.8 million people aged 65+ and social isolation impacts 0.6 million: 8% and 6% of the 65+ population in England respectively

## TV is the main form of companionship for two in five (38%) people aged 75 and over and nine out of 10 in this age group watch TV every day.

### Two in every five older people who are entitled to Pension Credit do not receive it.

### 31% of over-75s live in poverty or just above the poverty line.

Data extracted from DWP's Stat-Xplore shows that 1,577,985 pensioners aged 75 and over in the UK had incomes of less than 70% of the median income after housing costs in 2017/18, of a total of 5,057,955 people in this age group. This is 31%.

## Over 4 million older people live with one or more serious long-term health conditions, like diabetes and heart disease.
