Why we're campaigning

Cutting the Winter Fuel Payment this winter, with virtually no notice and no compensatory measures to protect poor and vulnerable pensioners, is the wrong decision.

We want the Government to halt their proposed change to the Winter Fuel Payment and think again.

Millions of struggling pensioners won't receive up to £300 they rely on to pay their bills.

We believe as many as 2 million pensioners who find paying their energy bills a real stretch will be seriously hit by this cut. There are 3 key groups we're worried about:

- Those who just miss out on Pension Credit because their very modest incomes are slightly too high for them to be eligible, usually because they have a tiny occupational pension. Many of them are women.
- Those with high energy needs because of disability or illness, and/or who live in energy inefficient homes which cost a lot of money to heat, estimated at 200,000 people.
- A million pensioners who don't receive the Pension Credit for which they are eligible because they do not claim it. The problem of low take up with Pension Credit is deeply entrenched, with about a third of all those entitled to it consistently failing to claim it over many years.

There's only been three months warning for this change – and older people will have expected to have this money in their pockets this year. There simply isn't long enough for many to work out another plan. The Government has said more will be done to encourage those entitled to Pension Credit to claim it but this will take time and won't stop many missing out this year.

To make matters worse, this isn't the only support with energy costs pensioners are losing meaning that pensioners could have £600 or more less this winter even though energy bills stay high.

This is because they are also losing:

- Cost of living payment to support with high energy costs over the last two years all pensioners received up to £300 on top of their Winter Fuel Payment in the last two winters. Those on low incomes or with a disability received more.
- The Household Support Fund delivered through councils which has provided help for some struggling older people is also ending in September.

This cut is happening in England and Wales. In Scotland and NI decisions about the payment are devolved, and not yet clear, but the UK Government will no longer provide the money to cover the cost of what pensioners in those nations receive now. So, the Scottish and Northern Irish governments will have to decide whether to cover the shortfall from their budgets.

The Government should halt their proposed change to the Winter Fuel Payment and think again.

Join us to protect struggling pensioners this winter.

What you can do to help

- If you have an hour: Write a letter to the Chancellor and your MP to tell them about how this decision affects you or a loved one and to ask them to reconsider.
- If you have longer: Meet your MP to talk about what they can do to help and to gain their support for the campaign!

Template email to your friends and family

Hi,

I'm really worried about the news that the Government is cutting the Winter Fuel Payment for those not on Pension Credit. Age UK estimates around 2 million pensioners who really need the money will now lose it.

Cutting the Winter Fuel Payment this winter, with virtually no notice and no alternative measures to protect poor and vulnerable pensioners, is wrong.

Writing to the Chancellor and your MP

Write a letter or email to the Chancellor, Rachel Reeves, and your MP. The more personal your letter is, the more both will see the human impact of the decision to cut the Winter Fuel Payment.

Find out who your MP is and their email address on the **UK Parliament website** (members.parliament.uk/FindYourMP). You can send post to your MP at *House of Commons, London, SW1A 0AA*.

If you receive a reply, please write your own response to it, and let us know what your MP or the Chancellor says. You can forward it on to us at **campaigns@ageuk.org.uk**, or by posting it to Freepost, Age UK Campaigns (no stamp needed!).

Tips for your letter

- Shorter tends to be better when writing to politicians as they are very busy.
- Write a subject line at the top of your letter about why you're writing to them, and what you'd like them to do.
- **Remember to stay polite** and it's always better to try to stay politically neutral.
- Share your own personal experiences about the Winter Fuel Payment, and what the effect of cutting it will be on you or your loved ones.
- Remember to say what action you'd like them to take: Your MP: you could ask them to write to the Chancellor, asking her to protect the people who will struggle without the Winter Fuel Payment. The Chancellor: you could ask her to save the Winter Fuel Payment.

Meeting your MP

Face to face meetings with MPs are a great way to show them just how important the Winter Fuel Payment campaign is for you. It allows you to talk directly to them and they'll think about the issues you raise. It's a very powerful way of both building a relationship with your MP, and of influencing how they respond to policy decisions – such as with the Winter Fuel Payment.

This guide sets out how to go about meeting your MP, and what you might like to ask them to do.

1. Organise the meeting

If you want to meet your MP to discuss the Winter Fuel Payment, the first thing you need to do is to contact them to organise a meeting or see if they have information on their website about an upcoming surgery.

You can find out who your MP is, their contact details, and website on the UK Parliament website

(members.parliament.uk/FindYourMP).

If you don't use the internet, you can write to them at *(name), House of Commons, London, SW1A 0AA.* You can also call the House of Commons switchboard (020 7219 3000). You can ask to speak to your MP, and they'll put you through – it's unlikely the call will be answered by the MP. It will probably either be an answering machine or member of staff.

Don't be disheartened if it takes a few weeks to get a reply to your email/letter! MPs and their staff receive a lot. If you haven't heard back after a few weeks, please do follow up your request with a polite phone call.

When organising the meeting, keep your message precise and brief. You may need to be flexible about when you meet and will probably be able to meet for 15-30 minutes.

As it is now Summer Recess, your MP should be in the constituency most days though may already have a busy diary! It is always best to organise a meeting in advance to make sure the MP has enough time to talk to you.

2. Let us know!

3. Preparing for your meeting

There are three main things to remember when you meet with an MP.

Firstly, don't be nervous! They won't expect you to be a policy expert, instead they'll be interested to hear about your personal experience. They might also have some useful resources that they want to share with you.

Secondly, don't be party political. Try to be polite and focus on the Winter Fuel Payment. Even if your MP doesn't agree with you about the Winter Fuel Payment, they may still decide to act on your behalf. Thirdly, have a think about what you want to say to your MP, and if there's anything that you want to ask them.

4. After the meeting

Stay in touch with your MP! Write to them to thank them for meeting with you, and to reiterate anything that either of you agreed to.
